You must submit all the necessary documents with the application, otherwise the application may be rejected.

- All documents have to be translated into English or Norwegian.
- All documentation must be in one-side-A4 paper and with no staples and pins.

Please tick off and sign below to confirm which documents you have submitted. Attach the Document Checklist to your application and **deliver the application in following order:**

1.	Passport, valid at least 3 months beyond intended travel, issued within the previous 10 years, and containing at least two blank pages.
2.	Applicant's Passport photo (white background) not older than six months (35-40MM).
3.	Signed Cover letter from the Online Application Portal.
4.	Print and fill out the Questionnaire for C-visa and submit it with your visa application. All questions in the form must be filled out. Find the questionnaire further below in this document.
5.	Invitation letter stating the purpose of the visit and the relation between the applicant and the inviting party/reference.
6.	Copy of the first and last page of the reference passport (last page only for Indian passport holders).
7.	Documentation of relationship if visiting family.
8.	Documents confirming employment, school or studies and permission for leave, and income if any.
9.	Copy of bank account for the last 6 months.
10.	The original UDI guarantee form for visit (attested by the police in Norway) if the reference is guaranteeing for the cost of travel and stay. If covering the cost of the visit yourself, you need to document to have NOK 500 per day/person e.g. in the form of a statement of account from your bank or a wage specification for the past six months.
	Original UDI guarantee forms will not be returned, a copy of the form will be sufficient while travelling.
11.	Original current passport and all previous passports.
12.	Confirmed booking of roundtrip air ticket, with fixed travel dates of maximum 90 days. Do not buy the ticket until visa has been granted. Note: If the application is approved, the visa will be issued according to the dates on the booking.
13.	A medical travel insurance is required with a minimum coverage of €30.000
14.	Letter granting Power of Attorney. (Optional for applicants who want another person to represent them in the case. <u>Separate form for Power of Attorney can be found here.</u>)

If you are under 18, you must also submit:

- If you are travelling alone: An original and a copy of letter of consent signed by both parents and legalized.
- If you are travelling with only one of your parents: An original and a copy of letter of consent from the other parent and legalized.
- If the parent you are travelling with has single custody: A shown original and a copy of certificate of single custody.

The Embassy may contact the applicant to request additional documents.
